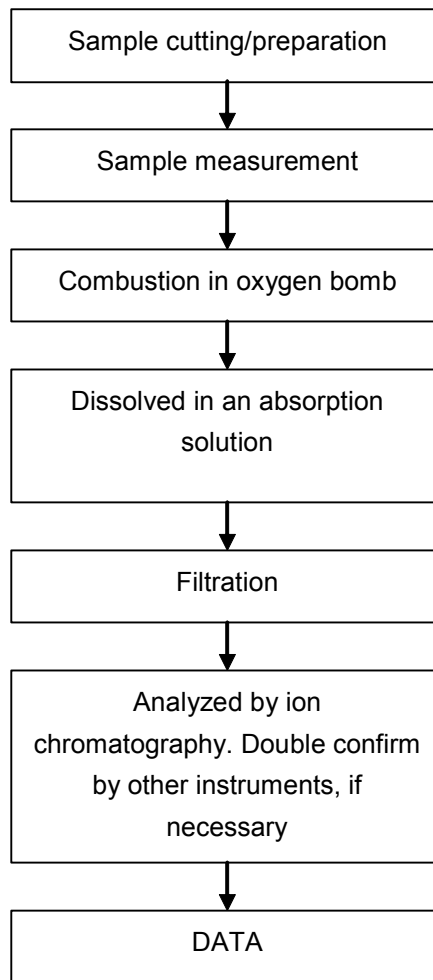

Halogen Testing (oxygen bomb) Flow Chart

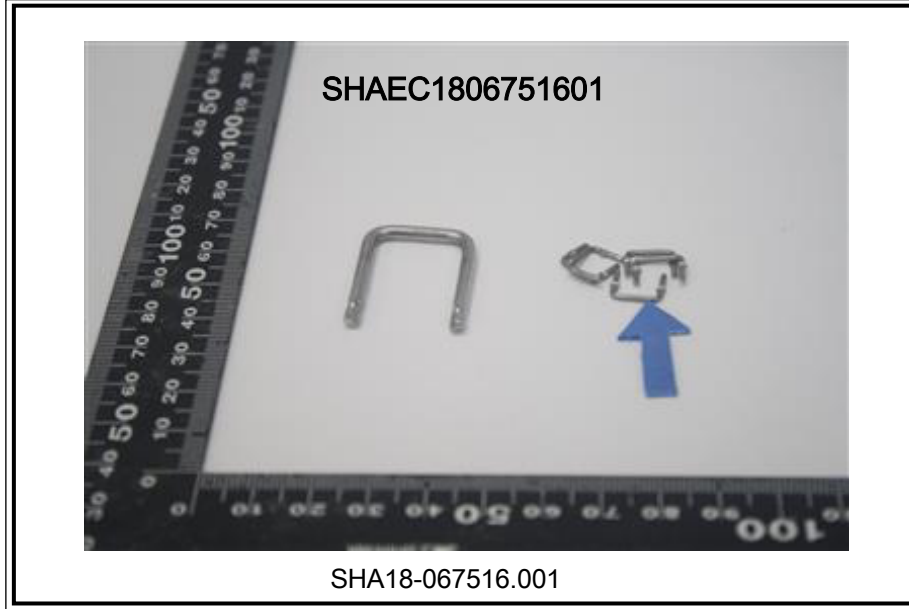
