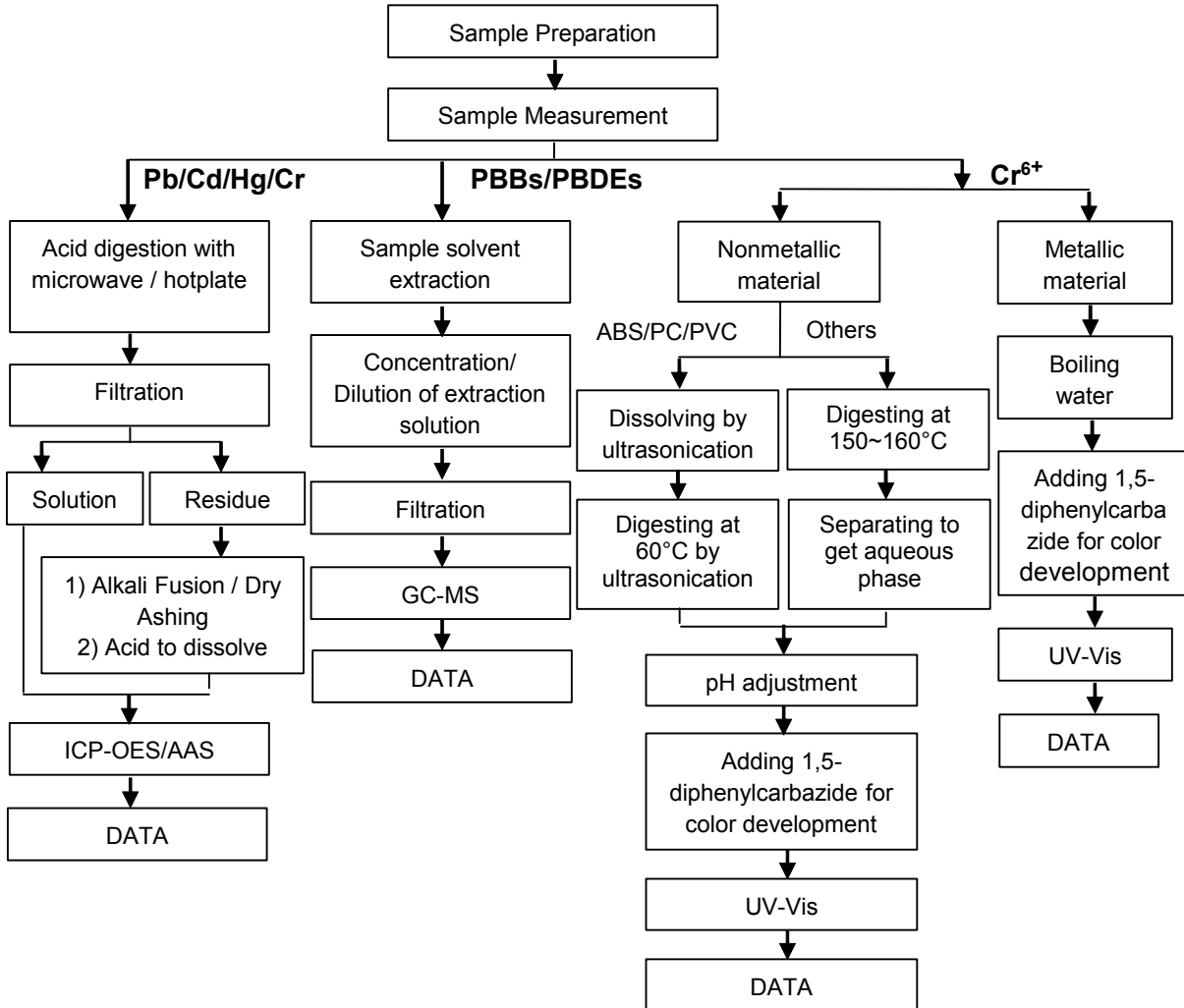

Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs Testing Flow Chart

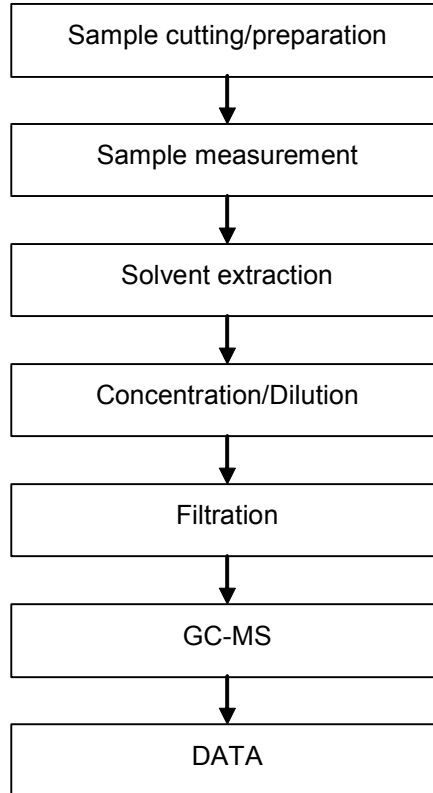

Phthalates Testing Flow Chart

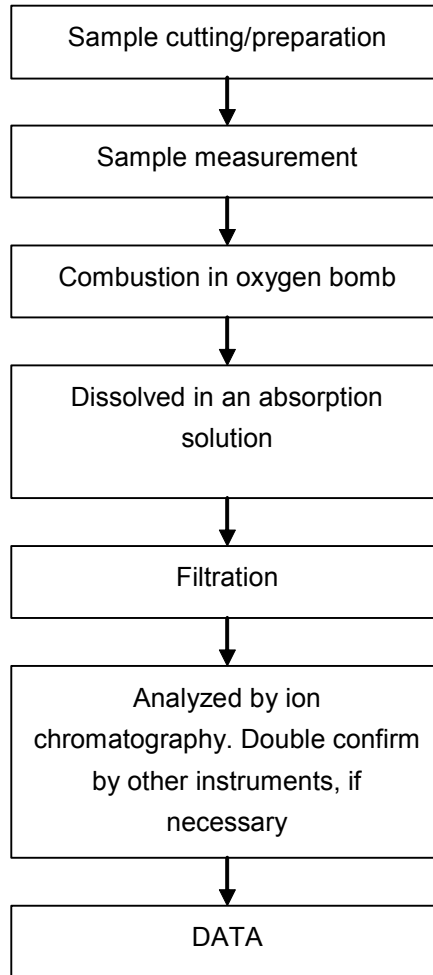

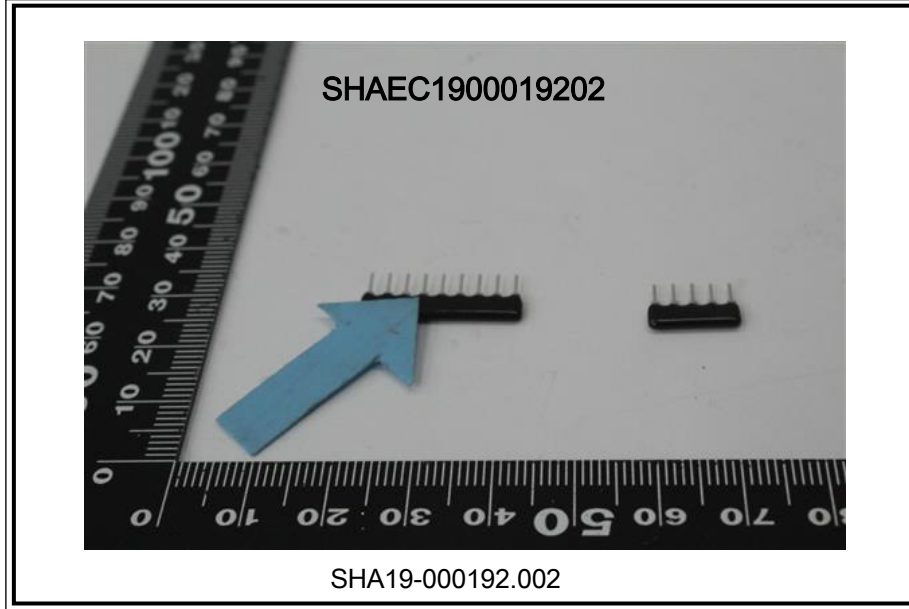
Halogen Testing (oxygen bomb) Flow Chart
