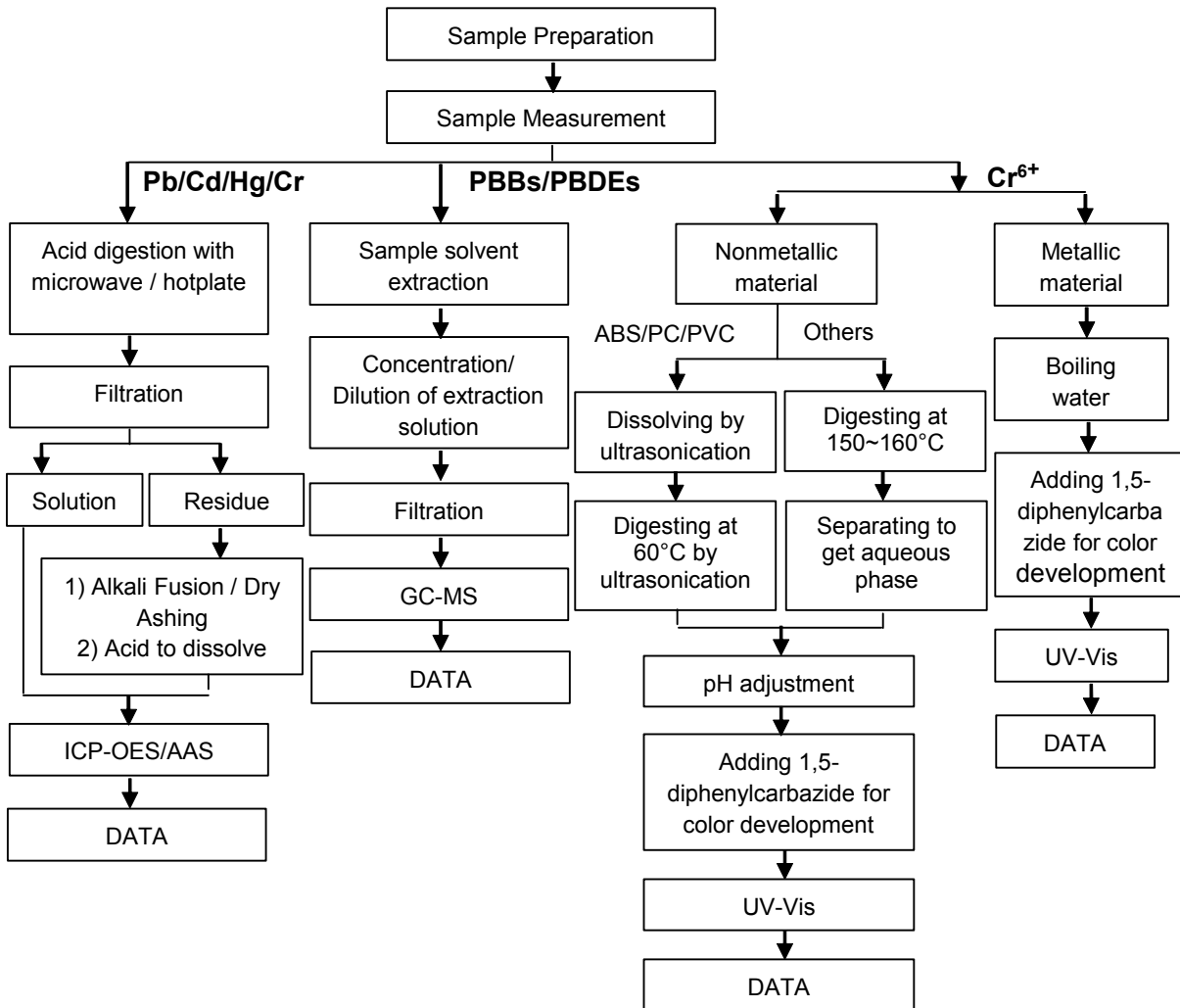

**Pb/Cd/Hg/Cr<sup>6+</sup>/PBBs/PBDEs Testing Flow Chart**

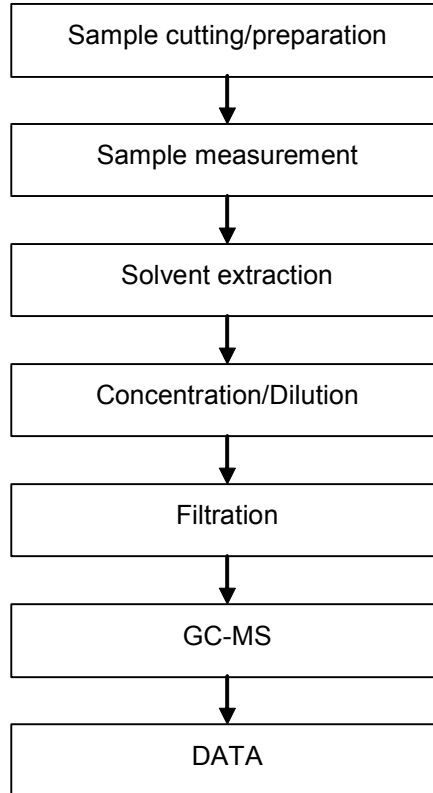

### Phthalates Testing Flow Chart

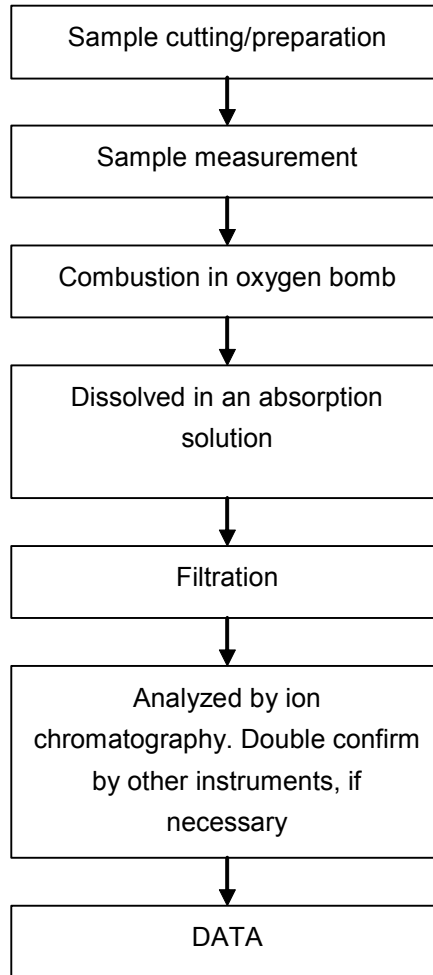

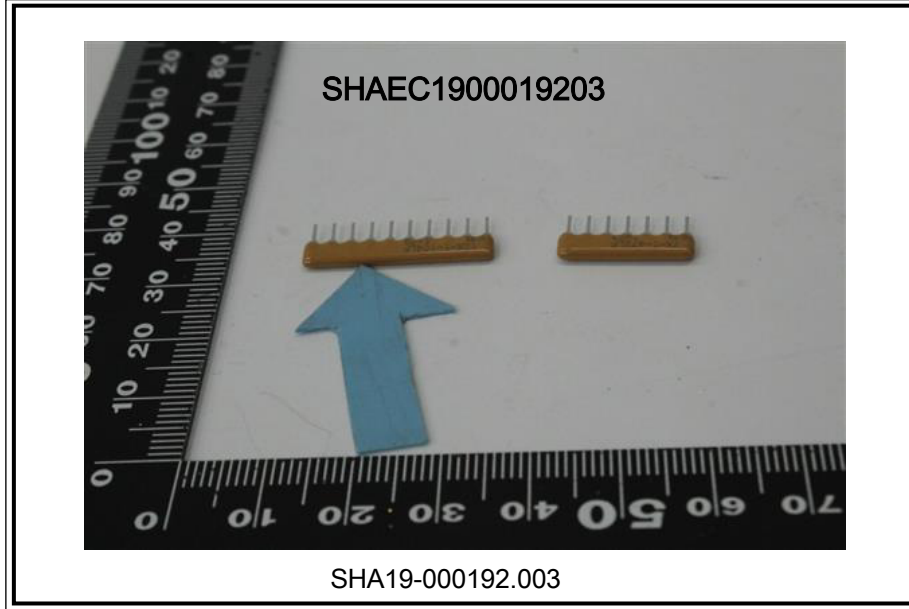
Halogen Testing (oxygen bomb) Flow Chart
